Format: Self-paced online training course delivered by Point Heard

- 3. Goal Setting
- 4. Selling goal aligned home care services

- Understand the language and experiences of older people
- Build sustainable trust-based relationships
- Set goals to deliver health and wellbeing outcomes
- Sell goal aligned home care and support services
